If you exclude yourself (opt out), you will not receive a monetary payment or other benefits from the Settlement and you cannot object to the Settlement. You will, however, maintain the right to sue 2 Towns Ciderhouse on your own individual claims, at your expense, regarding the claims being released in this Settlement and you will not be legally bound by the Settlement. I declare under the penalty of perjury that I purchased at least one (1) of 2 Towns Ciderhouse's eligible hard cider products, which include the following: Cider, Easy Squeezy, Pacific Pineapple, Made Marion, Ginja Ninja, or Outcider, Bad Apple, Cherried Away, Cot in the Act, Sun's Out Saison, Nice & Naughty, Rhubarbarian, Pearadise, Prickly Pearadise, Serious Scrump, and Imperial Hop & Stalk. These products must have had a label that contained the statement "Nothing artificial: No concentrates or refined sugars; No essences or artificial flavors; No velcorin or sorbate" or a substantially similar statement during the Class Period. I further acknowledge and understand that by opting out of the Settlement, I will not receive a monetary payment and that I cannot object to the Settlement.
